all that certain piece, parcel or lot of land in the State of South Carolina and in the Fourth Ward of the City of Greenville, beginning at an iron pin on the South side of East Washington Street, being the corner of lot No. 2 now owned by Mrs. Bessie Norris Tilman and running thence with line of Lot No. 2 (Mrs. Bessie Norris Tilman's line) South 29 3/4 East one hundred and sixty five (165) to an iron pin corner of Lot of M.
