(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said J. C. All those certain two acres, more or less of land situated lying and being near the Monaghan Mill, Greenville Township, in the State and County aforesaid, and being known as lots in Block "3" of Kivvick, as shown by plat of said property made by Carter and Pringle, Surveyors, recorded in R.
