


R. Mays Cleveland DEED TO Earle Pepper

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said Earle Pepper

all that piece, or parcel of land on Little Beaver dam branch waters of north Saluda River, near Marietta adjoining lands of Wm. Pritchett, Esq. Beginning on iron pin on Little Beaver dam branch thence down branch, S 10 1/2 W. 1.58 to iron pin thence N. 89 1/4 E. 6.33 to iron pin thence N. 10 1/2 E. 1.58 to iron pin, thence S. 89 1/4 W. 6.33 to beginning containing one acre.

(I agree to allow Earle Pepper the use of a ten foot alley over my land from his acre along Mrs Pritchett's line to Cleveland Avenue for entrance to + from his place.)

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said Augusta C. Squier, all that certain lot of land
