 NOW, KNOW ALL MEN BY THESE PRESENTS, That *I, Elma J. Gilstrap* in the State aforesaid  
 in consideration of the sum of *Eleven Hundred* DOLLARS,  
 to *me* in hand paid at and before the sealing of these presents by *Joe C. Smith*

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said *Joe C. Smith* his heirs and assigns forever all that piece, parcel and tract of land containing *5 1/2* acres more or less bounded by *Rice, Gilstrap and others* beginning at a post oak and running thence *N. 89 1/2 W. 6.65* to a post oak; thence *S. 53 W. 22.00* to a stone; thence *N. 6.00 W. 16.25* to a stone; thence *N. 71 E. 7.80* to stone; thence *N. 79 3/4 E. 14.30* to a stone or black oak; thence *S. 66 1/2 E. 9.50* to a stone; thence *S. 4-1/2 W. 15.30* to the beginning corner being the same land conveyed to *Joseph A. McCullough* by deed of *J. M. D. Terry, P. C. Terry and others* on November 17th, 1891, and *W. M. Gilstrap* of the same date and by *Joseph A. McCullough* to me on the 31st day of January 1912.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said *Joe C. Smith, his* heirs and assigns, forever.

AND *I* do hereby bind *myself, my* heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said *Joe C. Smith, his* heirs and assigns, against *me* and *my* heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
