NOW, KNOW ALL MEN BY THESE PRESENTS, That I, N. L. Shaw of Fountain Dupe,

in the State aforesaid  
in consideration of the sum of Thirty-four Hundred  
to me in hand paid at and before the sealing of these presents by Joe Gault of the County of  
Greenville DOLLARS,

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said  
Joe Gault, all that lot or parcel of land lying being  
and situate about one mile from Fountain Dupe, on  
the south side of the old stage road in County  
and State aforesaid, containing thirty-four acres,  
more or less, the same being a part of the land  
conveyed to me by A. B. Fowler and Lott the follow-  
ing metes and bounds to wit: J. W. O. Vaughan, J. O.  
Kellott and others, Commencing at a sweet gum run-  
ning thence N. 59 1/4 W. 9.37 to a stone 3x thence N 15 E  
14.38 to a point on branch, thence N 84 1/4 E. 81 links to  
center of Branch thence N. 32 1/2 W. 74 links to center of  
Branch thence N 22 1/2 E. 10.70 to center of road thence  
S. 66 1/2 E. 8.32 to bend in road thence S 66 E. 5.58 to an  
iron pin J. W. O. Vaughan's corner thence S 22 1/2 W. 28.20  
to a stone on J. O. Kellott's line thence N 32 1/2 W. 3.20  
to beginning corner.

heirs and assigns, against me and my heirs, and against  
every person whomsoever lawfully claiming or to claim the same, or any part thereof.
