 in the State aforesaid
 in consideration of the sum of *Two Dollars and other valuable consideration* DOLLARS,
 to *me* in hand paid at and before the sealing of these presents by *S. W. Seawright*

(The receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said *S. W. Seawright*, all that certain piece, parcel or lot of land in County and State aforesaid, and having the following metes and bounds to wit: Beginning at and iron pin, the northeast corner of lot conveyed to me by deed recorded in Vol. 34, page 27, this same point being on the side of Brockman St. and running thence with Brockman St. 60 feet to corner of Brockman St. and Seawright Street, which is a 16 foot street, thence with Seawright Street 95 feet, thence 99 feet in an easterly direction to a point in *J. T. Simpson's* line 98 feet distant from Brockman Street, thence in a northerly direction 98 feet to the beginning corner in Brockman Street.

This is the same lot of land upon which is situated three two-room houses and a church, and is a part of the same lot of land conveyed to me by deed recorded in Vol. 34 at page 27 in R. M. C. office for Greenville County.
