NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Mrs. Parthenia Whitt, of Greenville County
in consideration of the sum of one thousand (\$1000.00) DOLLARS,
to me in hand paid at and before the sealing of these presents by W.W. Whitt, of Anderson County, in the State aforesaid

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
W.W. Whitt, his heirs and assigns forever: All that certain piece, parcel or tract
of land lying and being situate in the County and State aforesaid, containing twenty and
one-half (20-1/2) acres, more or less, having the following bounds and meets to-wit:
Beginning at a stone X30m on west side of the Public Road, leading from Pelzer to Greenville,
running thence N. 85-1/2 E. 29.40 to a stone X30m; thence N. 9-1/4 E. 6.50 to stake X3, thence
S. 89-1/2 W. 26.64 to stone X3; thence S. 23-3/4 W. 9.22 to stone X30m to the beginning
corner, bounded on the south by lands of Lee Suber, on the east by lands of Reuben Scott,
on the North by lot #2 of the same Estate and on the West by lands of T.B. Bennett, known
as lot #1 of the estate of D.R. Whitt, deceased and more particular described by plat made
and certified to be Wm.F.Lee, Surveyor April 20th, 1914.
