NOW, KNOW ALL MEN BY THESE PRESENTS, That Horace A. Jansill of the
County and State aforesaid in the State aforesaid
in consideration of the sum of Ten (\$10.00) and other consideration DOLLARS,
to me in hand paid at and before the sealing of these presents by
W. R. Hale, Jr.

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

W. R. Hale, Jr.:
all that certain lot of land situate at Paris in
the County of Greenville, State of South Carolina
known and designated as lot #2 of the property
of W. D. Parrish, as shown on plat made by R. E.
Dalton, and recorded in Plat Book "E", page
46, and having the following metes and
bounds:

Beginning at a stake on the national High-
way, 50 feet from the western side of Mooney
Road, being the corner of lot #3, and running
thence with line of lot #3 n. 32-43 w. 50 feet to
stake in line of lot #5; thence with line of lot
#5 s. 53-40 w. 25 feet to stake, corner of lot #1; thence
with line of lot #1 s. 36-43 e. 50 feet to stake on
national Highway; thence with national High-
way n. 53-40 e. 25 feet to the beginning corner,
being the same lot conveyed to me by W. D.
