to me in hand paid at and before the sealing of these presents by
Susan M. Lee Barksdale

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
Susan M. Lee Barksdale her heirs and assigns,
all that certain tract of land situate in County
and State aforesaid about three and one half
miles from the City of Greenville known as
the Home Place of the late M. E. M. Barter con-
taining 107 and 25/100 acres more or less being
fully described by notes and bounds in the
deed from Mrs. Annice Payne and Mrs.
Pearl M. Barter to me dated the 13th of June
1917 and recorded in R. M. C. Office for Greenville
County in Volume 36 Page 272 and fully
shown by the plat of the same recorded in
said office in Plat Book "E" Page 45.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
