(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said W. M. Garrett all that certain piece or parcel of land situated, lying, and being in Austin Township, Laurens
 and State aforesaid, on south side of Greenville and Laurens wagon road, bounded by lands of William Ayers, W. M. Garrett, J. C. Forrester and others and
 having the following metes and bounds to wit:
 Beginning at stone, Garrett's corner, thence N. 80° E. 2126 to stone, thence N. 3 E. 7.50 to C. & L. wagon road, thence N. 68° W. along said road to Austin's line 6 $\frac{1}{2}$; thence S. 72° E. along said line 9 $\frac{1}{2}$ to the beginning, and
 containing 3 $\frac{1}{2}$ acres, more or less.
