NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Eva Good, of Greenville Property, in the State aforesaid, in consideration of the sum of Eight thousand (\$8,000.00) DOLLARS, to me in hand paid at and before the sealing of these presents by American Bank, a Corporation,

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said American Bank, a Corporation, its successors and assigns, all that certain piece, parcel or lot of land, situated, lying and being in the State and County aforesaid, and in the City of Greenville, between Pendleton and Augusta Streets, and having a frontage on said Pendleton Street of 22 feet more or less, and being 23 feet, more or less on Augusta Street, and extending from Pendleton Street through to Augusta Street, and designated as number 617, said lot adjoining the American Bank on one side, and the Dr. A. R. Bates property on the other. This being the same lot of land conveyed to me by L. B. Good by his deed dated 21st day of Feb'y. 1918 and recorded in the R. M. C. office for said County and State in Vol. #44 of Deeds, at page 177 to which reference is hereby made.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said American Bank, its successors, heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said American Bank, its successors, heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
