DEED TO Permelia A. Woodward

NOW, KNOW ALL MEN BY THESE PRESENTS, That I, B. O. Woodward, of Greenville County, in the State aforesaid in consideration of the sum of One hundred and twenty DOLLARS, to me in hand paid at and before the sealing of these presents by Mrs. Permelia A. Woodward

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Mrs. Permelia Woodward, her heirs and assigns, the following described real estate to wit: First: all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, and County of Greenville, in Grovel Township, at or near Goldsboro, Grovel, on the Greenville Piedmont dirt roads, and containing three (3) acres, more or less; this being the same land conveyed to me by W. D. Davis by deed dated November 1918 and recorded in the R. M. C. office for said County and State in Volume 43, of Deeds, at page 468. Second: All that certain piece, parcel or tract of land adjoining the above, and situate, lying and being in the same County, State and Township, and having of such metes and bounds as are shown in the deed from C. B. Tarrant to me, recorded April 28th, 1919 in Volume #44 of Deeds, at page 514, and containing 59/100 of an acre, more or less. Reference being hereby made to the deeds for a more complete description of said land.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Mrs. Permelia A. Woodward, and her heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Mrs. Permelia A. Woodward and her heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
