NOW, KNOW ALL MEN BY THESE PRESENTS, That J. P. Ballenger of the County of Greenville in the State aforesaid in consideration of the sum of Ten Dollars and other valuable considerations DOLLARS, to me in hand paid at and before the sealing of these presents by J. W. Ferguson and Emma May Ferguson

(The receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

J. W. Ferguson and Emma May Ferguson
all that certain piece, parcel or lot of land situated, lying and being in Greenville Township, State and County aforesaid, near the city of Greenville, in section known as New Society Hills, and beginning at a point on Young Street 170 feet from Franklin Road, and running thence with Young Street S. 7.25 E. 70 feet to a point 240 feet from Brockman Avenue; thence N. 19.20 E. 172 feet to a stake, thence N. 57.25 W. 40 feet to a stake which is 156 feet from Franklin Road; thence S. 27.30 W. 165 feet thence to the beginning corner, being the same lot of land conveyed to J. S. Mahaffey Jr. by Joe J. & C. C. Poole July 29th, 1915, and recorded in R.M.C. Office for Greenville County in Vol. 38 at page 90. Conveyed to me by J. S.
