NOW, KNOW ALL MEN BY THESE PRESENTS, That *W. A. Hammett and Robert Brockman*,
Trustees of Greenville County, in the State aforesaid,
in consideration of the sum of *Three Hundred and Fifty* DOLLARS,
to *me*, in hand paid at and before the sealing of these presents by *Mrs. Permeilia O. Bowlin*,
of Greenville County, S.C.
(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Mrs. Permeilia O. Bowlin, her heirs and assigns, all of
that certain piece, parcel and lot of land situate in
Greenville County and State aforesaid near Taylors Station,
on the south west side of Enoree River adjoining lands
of J. T. and G. M. Taylor and right of way of Southern
R.R. being a part of the land formerly owned by
Elmina Shookley and having the following written and
bounds, to wit:

Beginning at iron pins on Enoree River on
the right of way of Southern Railway and thence
with said right of way N. 85° W. 10.60 ft. chains to iron
pins on old line broken N. 24° E. 14.67 to Enoree River,
thence down the river and with the meander
there of 22.69 to the beginning corner, containing
ninet (9) acres, more or less.)
