G G Rogers, all that certain piece parcel of lot of land situate, lying and being, in the State of South Carolina, County of Greenville, in the City of Greenville, on the corner of Choice Avenue, and Breyer Street, having a frontage on Choice Ave. of 65 feet with a depth of 100 feet from Breyer Street, being the same lot of land conveyed to me by H. C. Cleveland, by Deed dated April 30th, 1909, and recorded in R. M. C. Office for Greenville County, in Vol. 4 at page 299, 11.
