DEED TO Mary J. Angel

NOW, KNOW ALL MEN BY THESE PRESENTS, That James Angel, of Greenville, County of Greenville, in the State aforesaid, in consideration of the sum of One Thousand and other good and valuable consideration, DOLLARS, to me in hand paid at and before the sealing of these presents by Mary J. Angel,

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Mary J. Angel, all that piece, parcel or lot of land situated in the City of Greenville, South Carolina, out the west side of Rowley Street, being known as the southern half of lot number 36 on plat made by J. C. Lorraine, October 6th, 1904 and revised by him May 27th, 1909 and both the following metes and bounds to wit: Beginning at corner of lot number 38 on Rowley Street; thence with Rowley Street N. 20° 19' E. fifty-two and one-half (52 1/2) feet to point whence N. 20° 19' E. fifty-two and one-half (52 1/2) feet to lot number 38; thence S. 67° 29' E. two hundred and ten (210) feet to the beginning corner, being the southerly lot of land conveyed to me by Mrs. Clara T. Arnold by deed dated February 6, 1912 duly recorded in the office of Register of Deeds Conveyance Book said. Little and County in Deed Book 19, page 76. As a part of the consideration for this deed the grantee agrees to assume and to pay a certain mortgage over said lot in favor of George T. Barb, originally given for \$200.00 with accrued interest, also a second mortgage over said lot in favor of Oscar Hodges, originally given for \$300.00 with accrued interest.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Mary J. Angel, her heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Mary J. Angel, her heirs and assigns, against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
