NOW, KNOW ALL MEN BY THESE PRESENTS, That Odella D. Freeman of Greenville County in the State aforesaid, in consideration of the sum of Twenty five DOLLARS, to me, in hand paid at and before the sealing of these presents by Ellen E. Montgomery

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Ellen E. Montgomery, all that piece, parcel and lot of land, lying, situate and being in the State and County aforesaid + Bates Township, known as a part of the land conveyed to me by deed from E. M. Freeman a dying lands of myself + Ellen E. Montgomery. Beginning on a iron pin on the South side of the new Jones Gap Road, thence running with said road N. 66 1/2 W. 5.00 to a bend in said road, thence N. 59 1/2 W. 4.50 to a stake in old road, thence with said old road S. 52 E. 5.00 to a bend in road, thence S. 75 E. 4.68 to the beginning and contains one fourth of an acre, be the same, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Ellen E. Montgomery, her heirs and assigns, forever.
