NOW, KNOW ALL MEN BY THESE PRESENTS, That *S. C. Fulmer of Fountain* in the State aforesaid,

in consideration of the sum of *One Thousand and five hundred* DOLLARS, to *me* in hand paid at and before the sealing of these presents by *Mamie Rose Fulmer of same place* (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Mamie Rose Fulmer All that lot or parcel of land lying being and situate ^{near the town of Fountain} in County and State aforesaid containing one and one fifth acres more or less, and had the following meter and bounds, to wit: bounded by *H. B. Dominick, M. M. Stevens, J. A. Adams* and others commencing at an iron pin *J. A. Adams* corner running thence *37 1/2 E. 4.78* to an iron pin thence *N. 86 1/2 E. 2.39* to an iron pin on *M. M. Stevens* line, thence *N 2 E 1.16* to *H. B. Dominick's* corner, thence *N. 56 E. 3.06* to center of road, thence *S. 84 7/8. 3.39* to *J. A. Adams* corner or beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said *Mamie Rose Fulmer and her* heirs and assigns, forever.
