Greenville County, South Carolina, in the State aforesaid,
in consideration of the sum of Five hundred Dollars,
to me in hand paid at and before the sealing of these presents by Donnie A. Quillen of
Greenville County, South Carolina

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
Donnie A. Quillen all that lot or parcel of land
lying being and situate in the Town of Fountain
Creek, County and State aforesaid and located on
Hector Street on the north east side, beginning
at a corner on L. G. Hughes line, running S 32 1/2 W
back to Hector Street, thence along Hector Street
211 1/2 feet and thence N. 32 1/2 E 411 1/2 feet back to L. G.
Hughes' line, thence S. 58 E. 188 feet along L. G. Hughes'
line to beginning corner, containing two acres, more
or less, and bounded by lands of said L. G. Hughes,
Sam Hughes, Hector Street and the public road.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
