

A. White DEED TO *T. L. Thornhill*
THE STATE OF SOUTH CAROLINA,

NOW, KNOW ALL MEN BY THESE PRESENTS, That *A. White*
in consideration of the sum of *Five Hundred* DOLLARS,
to *me* in hand paid at and before the sealing of these presents by *T. L. Thornhill*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

T. L. Thornhill, all those two certain pieces, parcels or lots of land situated, lying and being in the County aforesaid, about two and one half miles south of the City of Greenville, in vicinity of Falls, and being less or more and designated as lots Nos. 8 and 9, of section 2, according to a plat made by *H. D. Neve*, March, 1913, and is recorded in office of *R. M. C.* for Greenville County in Plat Book C at page 151. Said lots having the following metes and bounds to wit:

Beginning at a stake on the north side of *White Circle*, 90 ft corners with lots nos 9 and 16, and running thence N 27 W. 273.5 feet to a stake, thence N. 64 - 30 E. 200 feet to a stake on *Bradley Street*, thence with said *Bradley Street* S. 24 E. 244 feet to a stake at corner of *Bradley Street* and *White Circle*; thence with said *White Circle* in a westerly direction, 222.6 feet to the beginning corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

T. L. Thornhill, his heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said

T. L. Thornhill, his heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
