(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
C. L. Lankford all that lie or parcel or lot of land situate, lying and being in the State and County aforesaid in the town of Greer, and having the following metes and bounds: Beginning at a point on an unnamed street and runs N. 78-65 W. 128.6 feet to an iron pin; thence N. 78-35 W. 241.4 feet to an iron pin corner of lot No. 16; thence N. 11-15 E. 15 feet to an iron pin on line of Mrs. Morrow's property; Thence S. 67-53 E. 242.3 feet to an iron pin; thence S. 67-55 E. 135.4 feet to an iron pin on said unnamed street, thence S. 13-20 W. 79 feet to the beginning corner, being lots Nos. 19 and 46 on a plat of land called Brookville property made by P.
