NOW, KNOW ALL MEN BY THESE PRESENTS, That *J. H. McAlister* of *Greenville* County, in the State aforesaid, in consideration of the sum of *Five hundred and Sixty Two ⁰⁰/₁₀₀* DOLLARS, to *me* in hand paid at and before the sealing of these presents by *J. H. Coleman*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said *J. H. Coleman* all that piece parcel and tract of land lying situate and being in *Bates Township State and County aforesaid*, known as a part of the land conveyed to *me* *deed* from the heirs of *W. H. McAlister* estate adjoining lands of *Dave Talley* and *J. D. Coleman* beginning on a stone corner of *Dave Talley* thence running *N. 88 1/2 E. 800* to a stone thence *S. 64 E. 6.90* to a stone *N 77* thence *N. 4 N. 10.50* to an iron pin thence *S. 59 N. 12.20* to a pin *20m* thence *S. 10 N. 7.70* to the beginning corner and contains *10 ⁷⁵/₁₀₀* acres by the same more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said *J. H. Coleman* his heirs and assigns, forever.
