(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
John Chiles. All that certain parcel or tract of
land in Fairview Township County and State
aforesaid, bounded by lands of Mrs. Lula Huff
E. F. Griffin, John Chiles and others containing
seven acres more or less and having the
following metes and bounds to wit, Beginning
at stake at old road, Huffs line, thence N. 5
E. 10.87 to P. O. 3 x 0 m. Griffins corner, thence N. 48 1/4
E. 4.50 to Iron pin 7 m. thence S. 16 E. 13.23 to Iron
pin in Old road, thence down said road S. 81 1/4

John Chiles, his

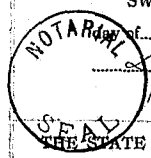
