Franklin Mill, All that certain piece parcel or lot of
 land situate lying and being in state and County
 aforesaid Chick Springs Township and in the Town of
 Kree and having the following metes and bounds
 to-wit beginning at a point on Hubert street and
 running with said street 80 feet to Mrs. E. D.
 Westmoreland's line thence along her line 130 feet to
 the Franklin Mill line thence along the side of the
 Franklin Mill 80 feet to Mrs. E. D. Westmoreland's corner
 thence along her line 150 feet to the beginning corner
