NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Allan J. Sullivan, of Greenville County, in the State aforesaid, in consideration of the sum of Five Hundred Dollars, to me in hand paid at and before the sealing of these presents by Walter Henderson et al. (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

Walter Henderson and Frank Henderson,  
 all that certain lot, or parcel of land, situated  
 lying and being in the town of Simpsonville,  
 County & State aforesaid, East of a street running  
 from old Georgia Road in a Northly direction  
 and running past in rear of S. J. Wilcox residence  
 beginning on his road line, 5 Jamie Wilcox corner,  
 and running thence N. 77 E. 190 1/2 feet to an iron  
 post, thence S. 14 3/4 E. 50 feet to an iron post, thence S. 77  
 E. 190 1/2 feet to an iron post in street, thence down
