NOW KNOW ALL MEN BY THESE PRESENTS, That I, J. N. Page of Greenville County  
in the State aforesaid,  
in consideration of the sum of Twelve DOLLARS,  
to me in hand paid at and before the sealing of these presents by J. W. Moon

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

J. W. Moon, all that certain piece or parcel or tract of land situated lying and being in Greenville County and in Highland Township being on the north east side of the road that leads out from the Rutherford road by J. P. Dille's mill and up to Pleasant Hill and over by Fate Campbell's gin and mill and lying right in front of J. W. Moon's house reaching down to the creek that runs J. P. Dille's mill, and up the road to the original line containing one fourth of an acre more or less, and adjoining lands of J. W. Moon and myself and others.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said J. W. Moon, and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said J. W. Moon and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
