NOW, KNOW ALL MEN BY THESE PRESENTS, That Arizona G. Mahaffy

in the State aforesaid,  
in consideration of the sum of Ten Dollars and other valuable considerations DOLLARS,  
to me in hand paid at and before the sealing of these presents by P. W. Smith

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

P. W. Smith, all that certain piece parcel of lot of land situate lying and being in the State and County aforesaid in which springs Township and adjoining lands of Tom Dill, F. P. Black and others, and having the following metes and bounds, to wit: Beginning at an iron pin in Tom Dills line also the South East Corner of Property conveyed by Arizona G. Mahaffy to F. P. Black and running thence N. 62, 30 W. 88 3/4 feet to an iron pin, north West corner of the F. P. Black land; thence S. 56, 40 W. 50 feet to a stake in center of road leading to Green S. Co.; thence with the meanders of said road, 174 1/2 feet to an iron pin, at forks of road; thence with road leading to the J. A. Mahaffy home place, N. 41, 50 E. 625 feet to a point in center of road the north-west corner of land owned by D. W. Gipsow; thence N. 10, 50 E. 791 feet to the beginning corner and containing 13 1/2 acres more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD all and singular, the said premises before mentioned unto the said P. W. Smith, his heirs and assigns, forever.
