to me in hand paid at and before the sealing of these presents by H. Endel of Greenville, S. C.,

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

H. Endel: All that piece, parcel or lot land in the City of Greenville, in the County and State aforesaid, on the north side of Whitsett St., and known as lot #4, of Block #12 on plat of the Boyce Larrn Property, and having the following metes and bounds: beginning at a stake on North side of Whitsett St., 216-3" from east side of Carolina Ave., and running thence along Whitsett Street N. 76-45 E. sixty eight feet and nine inches; thence N. 15. N. one hundred and twenty six feet and one inch to point on alley; thence along said alley S. 76-45. N. sixty eight feet and nine inches; thence S. 15. E. one hundred and twenty six feet and one inch, to the beginning point on Whitsett street, This is the same lot which was conveyed to me by A. L.
