NOW, KNOW ALL MEN BY THESE PRESENTS, That I M. M. M^e Milliam of the County of Spartanburg in the State aforesaid, in consideration of the sum of Seven Hundred Twenty five (\$725⁰⁰) DOLLARS, to me in hand paid at and before the sealing of these presents by

R. L. M^e Milliam of County of Greenville in the State aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said R. L. M^e Milliam, All one piece or parcel or lot of land Situated lying and being in County of Greenville & State aforesaid in west side of road leading from Greenville in direction of Greer, adjoining land of J. B. Kings, P. Turner, J. O. Weaver and R. L. M^e Milliam. Beginning at an iron pin, in new road and on S. E. Kings line, thence with S. E. Kings line N. 84.38 W. 17.50 to stone P. Turner corner, thence with Turners line N. 35 1/4 E. 11.54 to stone thence N. 87 E. 3.46 to stone in place of W. O. Bone, thence N. 20 3/4 E. 2.02 to stone in swamp, P. Turner and J. O. Weaver corner, thence with Weavers line N. 75 E. 4.97 to iron pin in road, R. L. M^e Milliam's corner thence with road S. 3 1/2 E. 1.29 to turn, thence with road S. 27 E. 7.40 to turn, thence with road S. 35 W. 3.68 to Beginning, containing seventeen & 3/4 100 acres more or less.
