

B. M. Dillard DEED TO R. B. Vaughan

NOW, KNOW ALL MEN BY THESE PRESENTS, That I, B. M. Dillard

in the State aforesaid,
in consideration of the sum of One Hundred fifty two and 3/100 DOLLARS,
to me in hand paid at and before the sealing of these presents by R. B. Vaughan

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said R. B. Vaughan all that certain piece, parcel and lot of land situate, lying and being in the State and County aforesaid, Chick Springs Township, near the incorporate limits of the town of Greenville, adjoining lands of R. L. Ford, Franklin Miles and others, and being a part of the group of lots Nos. 6, 7, 8 and 9 and a 45 foot alley on a survey made by A. R. Hood June 15th 1910 and having the following corners and distances: Beginning on R. L. Ford and R. B. Vaughan's corner and runs thence S. 22 1/4 W. 123.8 feet to an iron pin on Franklin Mill line, R. L. Ford's corner; thence S. 58 E. 90 feet to an iron pin; thence N. 22 1/4 E. 123.5 feet to an iron pin, corner of R. B. Vaughan and Odenport estate; thence N. 58 1/2 W. 90 feet to the beginning corner, containing 10, 880 sq. ft. more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said R. B. Vaughan and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said R. B. Vaughan and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
