 to *me* in hand paid at and before the sealing of these presents by
J. B. Rush

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
J. B. Rush, all that piece, parcel or lot of land situate
 lying and being on the Northwest side of *Green Avenue*
 in the City of *Greenville*, County and State aforesaid, beginning
 at an iron pin on said *Green Avenue*, and running
 thence N. 62 W. 87 1/2 feet to an iron pin on *W. P. Saporis*
 line; thence with said line S. 29 W. to an iron pin by
 a tree, 50 feet; thence S. 62 E. 89 feet to an iron pin on
 said *Green Avenue*; thence with the North west side
 of said *Green Avenue* N. 29 E. 50 feet to the beginning
 of corner, and containing 44 1/2 square feet more or
 less, situate in Ward Five of the City of *Greenville*
 and being the same lot conveyed to me by *Marshall*
