NOW, KNOW ALL MEN BY THESE PRESENTS, That W. D. Parrish

in the State aforesaid,  
in consideration of the sum of Five Thousand DOLLARS,  
to Me in hand paid at and before the sealing of these presents by W. F. Anderson

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said W. F. Anderson, All those two certain lots or parcels of land situate lying and being in the County of Greenville, State of South Carolina, on the north side of Augusta Road, known as lots nos. 15 and 16 as shown on plat made by C. S. Mercer, December 1918, and having the following whets and bounds, to-wit: Beginning at an iron pin on the north side of Augusta Road joint corner of lots nos. 14 and no. 15 and running thence with Augusta Road, S. 22.15 E. 180 feet to iron pin on Augusta Road, thence S. 16.10 E. 180 feet to iron pin on said Augusta Road, thence N. 64-55 E. 1,225 feet to center of Ridge Drive; thence North 25-15 W. 344 feet to iron pin in the center of Ridge Drive; thence S. 65.00 W. 1200 feet to point of beginning on the north side of Augusta Road, Being the same lots of land conveyed to me by Realty Corporation, by deed dated March 17th 1919, and recorded in the R. M. C. Office for Greenville County in Vol 25, Page 42.

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
