 NOW, KNOW ALL MEN BY THESE PRESENTS, That Anacour Fuller of Greenville
County in the State aforesaid,
 in consideration of the sum of ten Dollars and other considerations DOLLARS,
 to me in hand paid at and before the sealing of these presents by Jess M Ray

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Jess M. Ray: All that piece parcel or tract of land situate, lying and being in Brook Township, County and State aforesaid, and containing three and eighty four one hundredths (3.84) acres, more or less and having the following notes and bounds:

Beginning at iron pin 3x 3/4 m on J. H. Foster's line and running thence with said line S 15 1/2 E. 0.40 chs to iron pin 3x 1/2 m. thence N. 84 3/4 E. 29.36 to iron pin 3x 3/4 m. thence N. 88 40' W. 19.73 to iron pin 3x 3/4 thence S 73 1/2 W. 10.06 to the beginning corner and lying by lands of Jess Ray, J. H. Foster and other lands of Anacour Fuller.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Jess M. Ray and his heirs and assigns, forever.
