(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

R. D. Dobson, Lot no. 3 Block J. All that piece, parcel or lot of land in Chick Springs township, Greenville County, State of South Carolina, near the town of Greer land having the following metes and bounds: Beginning at a stake on the south side of Pennsylvania Avenue, and running thence N. 13.25 E. 120 feet to a stake on alley; thence S. 76.35 E. 70 feet to a stake on alley thence N. 13.25 E. 120 feet to a stake on Pennsylvania Ave. thence N. 76.35 E. 70 feet along said Avenue to the beginning corner.
