

Edward L. Henderson DEED TO Lula White

NOW, KNOW ALL MEN BY THESE PRESENTS, That I, Edward L. Henderson of Spartanburg County in the State aforesaid,

in consideration of the sum of Three Hundred + Fifty DOLLARS, to me in hand paid at and before the sealing of these presents by Lula White of the County of Polk State of North Carolina

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Lula White, A certain lot or parcel of land situate in Greenville County State of South Carolina, and lying on branches of Vaughn's Creek a tributary of North Catalet river and adjoining lands of Payne, Reuben McClure and Henry Rainer, and the remainder of my land; Beginning at a stake Henry Rainer's corner, thence S. 78 1/2 W. 7. 33 chains to a stake in place of Chestnut Grove, thence N. 56 W. 11. 26 chains to a stone, thence S. 50 W. Crossing a branch 15.00 chains to a stone, thence S. 60 E. Crossing a branch 18.25 chains to a small pine 37 N. W. thence N. 59 1/2 W. Crossing a branch 18.35 to a stake Henry Rainer's corner, thence with his line N. 26 1/2 W. 4.96 chains to the beginning containing twenty-eight and 2/100 acres more or less, said land being further known as a portion of the land conveyed to me by Wm. D. Weston, Dec. 28, 1909.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Lula White her heirs and assigns, forever.

AND I do hereby bind myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Lula White her

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
