 NOW, KNOW ALL MEN BY THESE PRESENTS, That I S. V. Chaudler of Greenville in the State aforesaid,  
 County Greenville in consideration of the sum of One thousand six hundred and no/100 DOLLARS,  
 to me in hand paid at and before the sealing of these presents by R. V. Chaudler

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said R. V. Chaudler, all that certain piece, parcel or tract of land situate lying and being in Paklawm Town-ship, County and State aforesaid and contains twenty four acres more or less and being more fully described as follows. Beginning on a stone 3x and the old Greenville road, thence N. 58 W. 20.25 to stake 37 thence N. 41 W. 1.25 to a stake 37. Thence N. 58 E. 17.75 to a stone 3x in old Greenville road, thence along said road N. 30 W. 12.50 to the beginning corner. Said layd being the same tract of land conveyed to me by R. S. Chaudler by deed dated March 2nd - 1886 and recorded in office of R. M. C. Forsgird book in deed book Page 497 and lying by lands of A. B. Sims, W. C. Stone and other lands of S. V. Chaudler and others -

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said R. V. Chaudler and his heirs and assigns, forever.
