NOW KNOW ALL MEN BY THESE PRESENTS, That I Sarah B. King of State of Texas and County of Cherokee in the State aforesaid, in consideration of the sum of One Hundred and twenty five DOLLARS, to me in hand paid at and before the sealing of these presents by Wamps N Kelly in the State aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said Wamps N Kelly, All that plat or parcel of land lying and being in the Episcopal Cemetery in the City of Greenville, S. C. said lot being No. 85 and the lot originally sold to Thomas Stern and sold by him to D. B. Lewis, situated and bounded as follows: Viz. on the north by Lot No. 86 twenty five feet, owned by J. H. David, on the East by the Main drive, Thirty one feet, on the South by lot No. 82, Seventeen feet, owned by W. C. Reynolds, on the West No. 83, thirty feet, owned by R. B. Brock,

(The conditions of the above sales viz that I the said S. B. King do hereby reserve the space in the above mentioned lot occupied by the graves of D. B. Lewis and his mother J. P. Lewis deceased, and also require the said W. N. Kelly to keep said graves neatly cleared)

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Wamps N Kelly, heirs and assigns, forever.

AND I do hereby bind myself my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Wamps N Kelly,

heirs and assigns, against every person whomsoever lawfully claiming or to claim the same, or any part thereof. and my heirs, and assigns
