(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said Sam Hill and Rebecca Hill, their heirs and assigns forever, all that certain piece, parcel or lots of land, situate, lying and being in Greenville County, near the City limits of Greenville, State of South Carolina, Beginning at an iron pin on the south side of Foster Street, corner of lots 13 and 14, running thence with Foster Street in 30° 52' 52" E 32 feet to an iron pin, corner of lot 15, thence with the dividing line of lots 15 and 16 31° 18' W 45.3 feet to an iron pin, corner of lots 13 and 4, thence with the dividing line of lots 4, 5, 14 and 15, (in a southeasterly direction) 42 feet to an iron pin, corner of lots 13 and 14, thence with the dividing line of lots 13 and 14 in 30° 54' E 40.9 feet to an iron pin, in edge of Foster Street, the beginning corner, and being lots 13, 14 and 15 as shown on plat and survey made by Wm. (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said J. L. Haley all that piece, parcel and lot of land situate, lying and being in Greenville County, in Ward Six, on Grove Street, and known as lots nos. 3 and 21, as shown on plat made by W. A.
