(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said Addie Sims, her heirs and assigns:

All that lot of land on Leach Street, Ward Five, in the City and County of Greenville, South Carolina, and having the following metes and bounds, to-wit: Beginning at a Stake 31 on Leach Street, and running thence along J. N. Hewell's line 100 feet to a Stake 34; thence northwest and parallel with Leach Street, 50 feet to a Stake 134; thence westward and parallel with J. N. Hewell's line, 100 feet to Leach Street to a Stake 34; thence along Leach Street to the beginning corner, and being the lower portion of Lot No. 10 of the J. N. (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto the said John D. Harris, Jr., and his heirs and assigns,

all that certain piece, parcel or tract of land situate, lying and being in the State of South Carolina, and County of Greenville; in Part Township, on the Augusta Road and having the following metes and bounds, to-wit: Beginning on said road at a stone 37, adjoining the B. S. Cox land, and running thence S. 87 1/4 E. 19.80 to a stone; thence N. 14-2, W. 9.20 to N.
