(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said J.W. Hill, his heirs and assigns forever, An undivided one-third (1/3) interest, of, in and to all that certain lot of land situate in the Town of West Greenville, in the County and State aforesaid, known and designated as Lot No. 6, of subdivision known as Providence, as shown by plat made by F.G. Rogers, Surveyor, and recorded in Plat Book A., page 411: Beginning at a stake on the North side of the extension of Pendleton Street at corner of Lot No. 5, and running thence N. 18-1/2 W. 80 feet to a stake; thence S. 85-1/2 W. 20 feet to a stake corner of lot No. 7, S. 18-1/2 E. 80 feet to a stake on Pendleton Street; thence N. 85-1/2 E. 20 feet to the beginning corner.
