(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

H. S. Hughes All of that certain piece, parcel or lot of land, situate, lying and being in Austin Township State and County aforesaid about one mile east of Simpsonville S. C. containing five acres more or less and described as follows:- Beginning at an iron pin in the Georgia Road, Stone on bank, near H. S. Hughes's residence, thence with the Georgia Road N. 80 E. 3.17 ch to corner in road, Stone on bank, thence N 9 W 14.00 ch. to Stone on A. R. Hunter's line; thence S 80 W 4.00 ch. to a stone; thence S. 12 E. 14.00 ch. with H. S. Hughes's line to the beginning corner.

Hughes and his heirs and assigns, against myself, my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
