KNOW ALL MEN BY THESE PRESENTS, That D. W. Moore,

in the State aforesaid,

in consideration of the sum of

Two Hundred Fifty (\$250.00) DOLLARS,

to me in hand paid

at and before the sealing of these presents by Hendrix Rector

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Hendrix Rector, all that tract of land in said County and State, on the Dixon Road, about three miles from Greenville Court house, containing one half acre, (1/2) more or less, being on the north side of said Dixon Road and bounded by lands of Henry Bates, Jack Fields and W.P. Vaughan, and having such meter and bounds as will appear by reference to the plat of survey of same by W. A. Hudson, and being a part of that lot of land conveyed to me by Elida Walker on February 19th 1913, by Deed recorded in R. M. C. office, Vol. 92 page 216, reference to same being hereby craved. I hereby represent that I have a good fee-simple title and that there are no incumbrances by way of mortgage or judgment or otherwise, against said property, the abov lot having the following meter and bounds as surveyed by W. A. Adams, beginning at iron pin in the Dickson road and thence N. 19 W. three hundred and twenty feet to a stone 370 W., thence N. 68 E. sixty seven feet to stone by perpendicular, thence S. 19 E. three hundred and forty five feet, to iron pin on road, thence along said road S 84 W. sixty seven feet to the beginning containing one half acre more or less.
