Blackwood, all that piece parcel or lot of land located on the South side of Earl Street between Wilton and Robinson Streets in Ward One of the City of Greenville in Greenville County, State of South Carolina, and known as lot 87, map 6 of lands of Mountain City Land and Improvement Company and having the following meters and bounds to wit. Beginning at a stake 217 1/2 feet west of Wilton Street on West Earl Street, thence N. 84 1/2 W. 54 1/3 feet to a stake corner lot M. thence with line of last mentioned lot S. 5 1/2 W. 200 feet to stake; thence S. 84 1/2 E. 54 1/3 feet to a stake; thence N. 5 1/2 E. 200 feet to beginning corner this being one of the two lots conveyed to me by Mountain City Land and Improvement Company by Deed dated January 7th 1895.
