(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Alberta T. Muckefuss, All that certain piece, parcel or lot of land in the City of Greenville, County and State aforesaid being a portion of Boyce's Addition to Greenville, in Ward 2, and being bounded and designated as Lot No. 1, Block 8, according to a plat on record in R. M. C. office for Greenville County, and having the following lines and bounded to wit: Commencing at an iron pin on the Northeast corner of Boyce Avenue and Whitsell St; thence N. 15° 0' W. along Boyce Avenue 126 feet and one inch to an iron pin on a ten foot alley; thence N. 76-45 E. along said alley 71 feet and 8 inches to an iron joint corner lot No. 1 and 2; thence S. 15° 0' E. along joint lines of said lots 126 feet and one inch to an iron pin on Whitsell St; thence S. 76-45 W. along said street, 71 feet and 8 inches to an iron pin the beginning corner as per survey of J.
