(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said
 W.V. Waldrop, J.A. Waldrop and S.V. Waldrop, All that piece, parcel and tract of land
 lying, situate and being in Bates Township, State and County aforesaid, known as a part
 of the land conveyed to W.V. Waldrop, J.A. Waldrop, S.V. Waldrop and Jesse R. Waldrop
 by deed from Sallie Goodwin. The same being on the West side of North Saluda River:
 Beginning at the cross roads of the old Marietta Road and the Keeler Mill Road, running
 thence with Keelers Mill Road S. 85-1/2 E. 3.71 to a bend; thence S. 41 E. 8.85 to a bend;

 bend; thence S. 78 E. 1.50 to a stake; thence N. 12-1/2 E. 1.82 to a stake; thence N. 14-3/4
 W. 1.91 to a stake; thence N. 17-1/4 W. 2.00 to a stake on E. bank of river; thence up
 River as the line 20.50 to a ditch, Jesse Bates corner; thence N. 65-3/4 W. 4.64 to an
 iron pin on ditch; thence down ditch S. 22 W. 3.80 to a branch; thence up branch N. 70
 W. 4.87 to a stake; thence N. 15-1/2 E. 2.12 to an iron pin; thence N. 88 W. 11.80 to iron
 pin; thence S. 48 W. 2.25 to a stone in branch; thence up branch 15.12 to a W.O. X30M;
 thence S. 77 W. 4.00 to an iron pin on the Marietta Road; thence down & with said road
 33.73 to iron pin in road; thence S. 64-3/4 E. 1.75 to iron pin; thence N. 44 E. 24.45 (1613.7)
 to iron pin on the Keeler Mill Road; thence up said road 4.00 to fork of road; thence N.
 57 E. 7.00 to bend in road; thence N. 78 E. 5.30 to bend; thence N. 66-1/2 E. 5.82 to
