(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said Deborah Burns, All that certain piece, parcel and lot of land situate, lying and being in the County and State aforesaid in a sub-division of land known as "Park Place" B, near the City of Greenville, a revised plat of which is recorded in the Register of Mesne Conveyance office for the County of Greenville, S.C. in plat Book "A", at page 119; said lot being No. 16 on said plat in Block "J", and being a part of the tract of land which was sold and conveyed to J.W.
