in the State aforesaid, in consideration of the sum of *Seventy Five Hundred (\$7500.00)* DOLLARS, to *me* in hand paid at and before the sealing of these presents by *Mrs. Mary C. Martin*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Mrs. Mary C. Martin, All that certain piece parcel or lot of land, situate, lying and being in the State of South Carolina and City and County of Greenville, in the First Ward of said City on Hampton Avenue and having the following metes and bounds, to-wit Beginning at a iron pin on the East side of Hampton Avenue and running thence N. 40 E. 231 feet to a iron pin on Suten Foot Alley, thence N. 43.44 W. 60 feet to a iron pin on a Twenty foot Alley, thence S. 40 W. with said alley 223 1/2 feet to Hampton Avenue; thence S. 36.13 E. with said Hampton Avenue 60 feet to the beginning corner this being the same lot of land conveyed to me by Effie B. Sloman by deed dated March 2nd, 1918, and recorded in Vol. 45 page 326, in R. M. C. office for Greenville County, South Carolina. This deed is executed subject to the mortgage given by Effie B.
