

TITLE TO REAL ESTATE.

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

R. H. Stewart the following, described real estate in the City of Greenville fronting on Buncombe Street and described as follows: All that certain lot of land situated in the City of Greenville near the corner of Duncan and Buncombe streets, beginning at a point on Buncombe Street 66.6 feet from the corner of Duncan and Buncombe Streets at an iron pin, thence with Buncombe Street N. 34° 45' W. 66.6 feet to an iron pin corner of lots 2 and 3, thence with the line between lots 2 and 3 S. 26° 2' W. 185 feet to an iron pin on the line between lots 1, 2 and 3 and 4, thence with said line S. 48° 45' E. 59.7 feet to an iron pin, thence with the line between lots 1 and 2 N. 25° 50' E. 167.5 to the beginning corner. All that certain lot of land situated in the City of Greenville near the corner of Duncan and Buncombe Streets beginning at a point on Buncombe Street, 133.2 feet from the corner of Duncan and Buncombe streets, at an iron pin, thence with Buncombe Street, N. 34° 45' W. 66.6 feet to an iron pin, corner of lot owned by Emily Beattie, thence with the line between this lot and the lot of Emily Beattie and others, S. 26° 15' W. 202.5 feet to an iron pin corner of lots 3 and 4, thence with the line between lots 3 and 4 S. 48° 45' E. 59.7 feet to iron pin corner of lots 2 and 3, thence with the line between lots 2 and 3 N. 26° 2' E. 185 feet to the beginning corner.
