 A certain parcel or tract of land situated in the County and State aforesaid, and in the branch water of Rocky Creek, branch water of Square River, containing 60 acres, more or less, beginning on a stone 34; thence N. 133, N. 12.35 to a P.O. 340; thence N. 58, N. 20.00 to a P.O. 340; thence S. 30 N. 6.64 to a chestnut 340; thence S. 8 1/2 N. 14.85 to a black Jack 340; thence S. 10 3/4 E. 12.43 to a hickory 340; thence S. 2 1/4 N. 3.00 to a stake 340; thence S. 57, E. 3.45 to a stone 34; thence N. 57 E. 26.00 to the beginning of a certain other tract of land adjoining the above, containing 1/2 a acre more or less, beginning at a stone 34; thence S. 43 1/2 N. 16.00 to a stone 34; thence N. 51 1/4 N. 14.22 to a stone on old line 34; thence N. 33 3/4 E. 30.83 to a chestnut stump, by R.
