(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *Oliver W. Leonard, one-half interest in all that lot or parcel, tract of land*

situated, lying and being in the County of Greenville, State aforesaid on the north side of Gilder's Creek, being a part of the land bought by J.D. Leonard from J. Thomas Austin, March 18th, 1886, known as the Austin Place, Recorded in Book "RR", page 626.:
